### SMOKE/CARBON MONOXIDE DETECTORS

Smoke/carbon monoxide detectors are placed in the units as preventive measurements for fires and carbon monoxide which is hard to smell and remains closer to the ground whereas smoke rises. Both are essential for saving lives. According to the National Fire Protection Association, an average of 1,450 fire deaths occurs every year in homes with missing or nonfunctioning smoke alarms.

### DO NOT DISCONNECT OR REMOVE Smoke/Carbon Monoxide DETECTORS FROM INSTALLATION.
